Inhalation

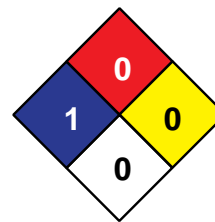

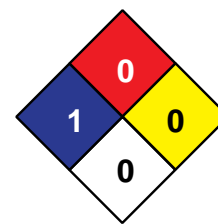
